 - (c) the 12th October, 2020 (Monday), as the last date for the withdrawal of candidatures;
 - (d) the 28th October, 2020 (Wednesday), as the date on which a poll shall, if necessary, be taken; and
 - (e) the 05th November, 2020 (Thursday), as the date before which the election shall be completed; and

(B) **fixes the hours** from **8.00 a.m. to 5.00 p.m**., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
